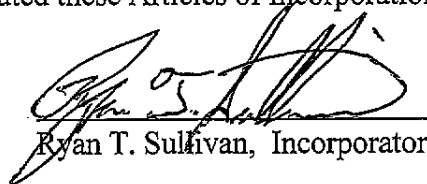

INITIAL OFFICERS AND DIRECTORS

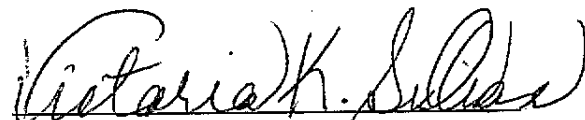
