ARTICLES I - NAME

The name of the corporation shall be A/C-Fix, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence and shall commence upon filing hereof.

ARTICLE VIII - INCORPORATIONS

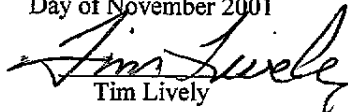

ARTICLE X - SUBCHAPTER S

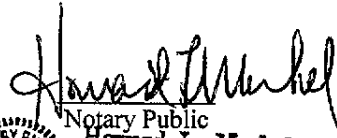

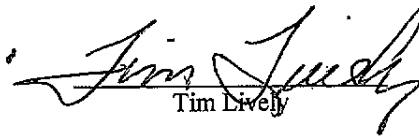
