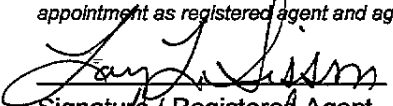

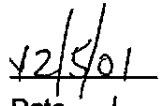

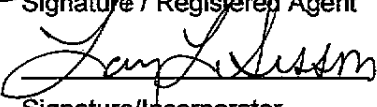
ARTICLE VIII

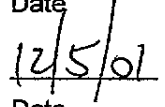
