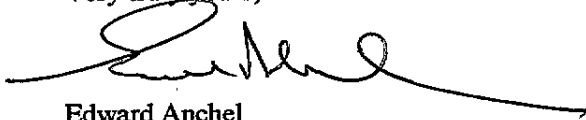

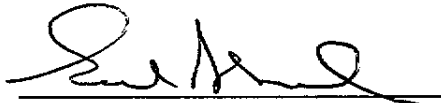
The corporation shall have all of the Corporate Powers enumerated in the Florida General Corporation Act.

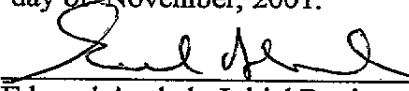
