# ARTICLES OF INCORPORATION TOKU FOOD GROUP, INC.

The undersigned subscriber to these Articles of Incorporation, Richard Gonzalez, being natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

#### ARTICLE I

### CORPORATE NAMÉ

The name of this Corporation is TOKU FOOD GROUP, INC. The principal office and mailing address of the corporation is 1380 24th Avenue N.E., Naples, Florida 34120.

#### ARTICLE II

#### DURATION

The Corporation shall have perpetual existence, commencing upon the filing of these articles with the Florida Secretary of State.

#### ARTICLE III

#### **PURPOSE**

## CAPITAL STOCK
