ARTICLE I- NAME

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of servicing, repairing and replacing all types and brand named Appliances, such as Refrigerators, Washers, Dryers, Dish Washers and everything associated with Appliances and Air Conditioners of all types and kinds to the public and private sector and to transact any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended including but not limited to the general work with service and repair Appliances and Air Conditioners.


