

ARTICLES OF INCORPORATION
OF
SERVICES DIAMOND, INCORPORATED

ARTICLE I

NAME OF CORPORATE ENTITY: The name of the corporation shall be Services Diamond, Incorporated.

ARTICLE II

EXISTENCE: The duration of the corporation shall be perpetual, commencement of the corporation shall begin as of the date and time of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III

GENERAL PURPOSE: The general purpose for which this corporation has been organized includes the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida or the laws of the United States.

ARTICLE IV

SHARES OF STOCK: The aggregate number of shares under which the corporation shall have authority to issue shall be one thousand shares of common stock with a par value of One Dollar (\$1.00) per share.

ARTICLE V


