ARTICILES OF AMENDMENT TO THE ARTICLES ON INCORPORATION OF THE WINDWARD CORPORATION OF JACKSONVILLE

- 1. The name of the corporation is: THE WINDWARD COPRORATION OF JACKSONVILLE.
