ARTICLES OF INCORPORATION OF X- THIRTIEN INC.

ARTICLE I - NAME

The name of the Corporation shall be X-THIRTIEN, INC. and the mailing address of the Corporation shall be 18002 Richmond Place. Dr. #321; Tampa, Florida 33647

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of operating a music management and promotion enterprise and conducting any other lawful business.
