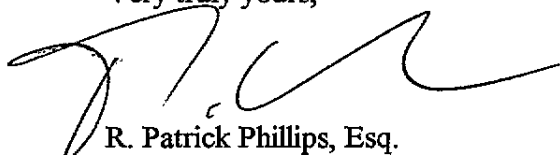

**ARTICLES OF INCORPORATION
OF
AMERICAN CUSTOM CONCRETE, INC..**

ARTICLE I - NAME OF CORPORATION

The name of this corporation is AMERICAN CUSTOM CONCRETE, INC.

ARTICLE II - PURPOSES

This corporation is organized for the purpose of transacting any or all lawful business pursuant to the provisions of Chapter 607, Florida Statutes.

ARTICLE III - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is 7,000, all of which shall be common shares. 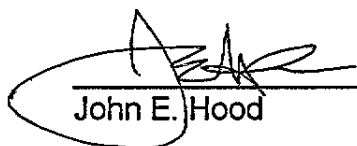

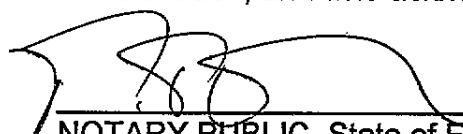
