The undersigned subscriber to these articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that they are also a director of such subsidiary or corporation.
