UNDER THE FLORIDA GENERAL CORPORATION ACT, DOES HEREBY ADOPT
THE FOLLOWING ARTICLES OF INCORPORATION:

ARTICLE I

PROFITS AND LOSSES IN ANY TRANSACTION OF TRANSACTIONS.


