ARTICLES OF INCORPORATION

State of the state The undersigned incorporator, for the purpose of forming a corporation under the Florida, Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I-NAME

The name of the corporation shall be: Hutchins Enterprises, Inc..
