ARTICLES OF INCORPORATION
OF
QUICKTIME MOTORSPORTS, INC.

The undersigned, for the purpose of forming and organizing a corporation for profit under the provisions of the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Quicktime Motorsports, Inc.

ARTICLE II - PURPOSE

The corporation is authorized to engage in the licensed practice of any activity or business.

ARTICLE III - PRINCIPAL OFFICE

The principal place of business and the mailing address of the corporation shall be:

521 Whitfield Avenue
Sarasota, FL 34243

ARTICLE IV - CAPITAL STOCK

The corporation is authorized to issue 10,000 shares of common stock having a par value of \$.01. Each share of common stock shall entitle the holder thereof to one vote on each matter considered at any stockholder's meeting. Said share shall be paid for in lawful money of the United States of America, or in property, labor or services rendered at a just valuation to be fixed by the Board of Directors and said share shall be deemed fully paid and nonassessable. The Corporation elects to have preemptive rights.

No shares of the capital stock of Quicktime Motorsports, Inc. may be issued or transferred to anyone other than a professional corporation, a professional limited liability company, or an individual who is duly licensed or otherwise legally authorized to render the same specific professional services as those for which the corporation was incorporated.

ARTICLE V - DURATION

This corporation shall have perpetual existence unless sooner dissolved according to law.

ARTICLE VI - SHAREHOLDER VOTING REQUIREMENTS

When a quorum exists at any meeting of the Shareholders, action on a matter, other than the election of Directors, is approved if the votes cast by the holders of not less than a majority of the shares represented at such meeting, and entitled to vote on the subject matter favor the action.

ARTICLE VII - DIRECTORS

ARTICLE IX - BYLAWS

The corporation shall pay all costs, legal expenses, and other charges that said officers and directors may incur in the defense of any claim, suit or action that may be instituted against said officers in their individual capacity. It is the express purpose and intent that the corporation shall hold its officers and directors harmless for any action taken by them on its behalf to the full extent and limit permitted by law.




