The undersigned, for the purpose of forming a corporation under the provision of ARY OF STATE Chapter 607, Fla. Stat., the Florida Business Corporation Act, hereby states the Ablawiag SEE FLORIDA

ARTICLE I - NAME AND ADDRESS

Section 1. The name of the Corporation shall be MediaMinds, Inc.
