ARTICLE I

NAME

The name of this corporation is Jonube Corp.



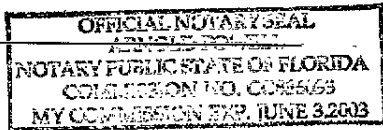
