ARTICLES OF INCORPORATION OF FRESH PRODUCE OF JACKSONVILLE, INC.

The undersigned subscribers to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida, effective December 01, 2001.
