The undersigned, acting as incorporator of GIMABE HOLDINGS, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I.**NAME**

ARTICLE II.**COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE III.**AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$1.00 per share.
