ARTICLE I - NAME

The name of the Corporation is: GARZA DRYWALL, INC.

ARTICLE XI - AMENDMENT

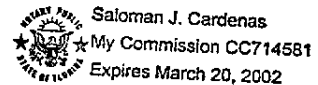
This Corporation reserves the right to amend or repeal any provisions contained in the Article of Incorporation, in accordance with the provisions of the Florida General Corporation Act.
