ARTICLE I

NAME OF CORPORATION

The name of the corporation shall be ADVENTURE ENTERPRISES & ASSOCIATES, INC.

ARTICLE II

NATURE OF BUSINESS

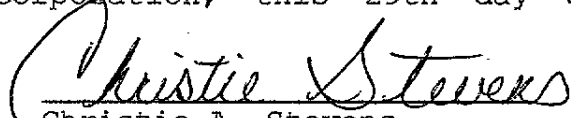

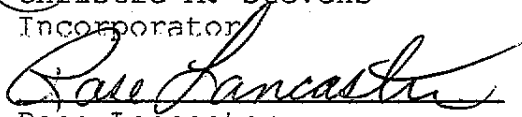

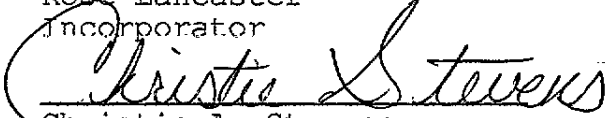
AMENDMENT OF ARTICLES
