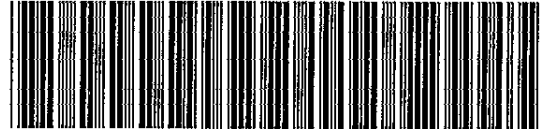

**AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
ALBERT R. LUPER, INC.**

Pursuant to the provisions of Section 607.100~~6~~ of the Florida Business Corporation Act, the undersigned corporation adopts the following Amendment to its Articles of Incorporation:

1. The name of the corporation is Albert R. Luper, Inc.
2. The following amendment to the Articles of Incorporation was adopted by all of the Directors and Shareholders of the corporation on October 21, 2002, in the manner prescribed by Section 607.1003 of the Florida Business Corporation Act:
