#### ARTICLES OF INCORPORATION

OF

#### AMERICASH CHECK CASHING, INC.

We, the undersigned, in order to form a corporation under and pursuant to the provisions of the Law of Florida for the purposes set forth below, hereby subscribed to these Articles of Incorporation.

#### ARTICLE I - NAME

The name of the corporation shall be: AMERICASH CHECK CASHING, INC.

#### ARTICLE II - PURPOSE

The purposes and general nature of the business to be conducted and transacted by the corporation shall be as follows:

- A. To do and transact any and all business as permitted under the laws of the State of Florida and the United States of America.

To guarantee, purchase, hold, sell, assign, transfer, mortgage, pledge or otherwise dispose of the shares of capital stock, or any bonds, securities, or other evidences of indebtedness, created by any corporation and while owner of such stock or evidences of indebtedness, to exercise all of the rights, powers and privileges of ownership, including the right to vote according to the rights of said instruments and agreements.

The amount of capital with which this corporation shall begin business shall be \$1000.00.

The existence of this corporation shall be perpetual.
