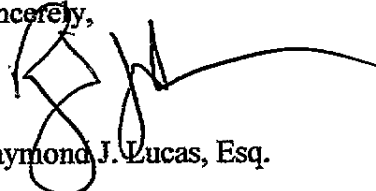

ARTICLE I CORPORATE NAME

The name of this corporation is Jupiter Food & Fuel, Inc.

ARTICLE II NATURE OF BUSINESS AND POWERS
