ARTICLE I
CORPORATE NAME, PRINCIPAL OFFICE
AND MAILING ADDRESS

The name of this Corporation shall be: **G & R HOFFMAN ENTERPRISE, INC.**, with its principal office located at 161 Hibiscus Road, Edgewater, Florida 32141 and its corporate mailing address being the same.

ARTICLE II
NATURE OF BUSINESS AND POWER
