
To Whom It May Concern:

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation for such corporation:

- FIRST: The name of the corporation is AMERICAN PAINTING SYSTEMS, INC.
- SECOND: The period of its duration is Perpetual.
- THIRD: The purpose(s) for which the corporation is organized are contract painting (residential & commercial), home repair work, electrical, plumbing and other minor repair work and any other lawful business activity for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of common stock having no par value or amount of par value each.
- FIFTH: The corporation will not commence business until at least one thousand dollars (\$1000.) have been received by it as consideration for the issuance of shares.
- SIXTH: Cumulative voting of shares of stock is not authorized.
- SEVENTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: None.
- EIGHTH: Provisions for the regulation of the internal affairs of the corporation are: governed by the bylaws which shall be adopted by a majority of directors.
- NINTH: The address of the initial registered office of the corporation is: 3501 W. Vine Street, Suite 344, Kissimmee, Florida 34741 and the name of its initial registered agent at such address is Paul J. Svejda.
