ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of this corporation is SOUTHLAND COMMUNICATIONS, INC. and the principal address is 6325 Arlington Road, Jacksonville, Florida 32211.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which a corporation may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended. The primary business will be communications.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 10,000 shares of One Dollar par value common stock which shall be designated as "Common Shares".

ARTICLE V - PREEMPTIVE RIGHTS
