The undersigned Incorporator(s), for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I. NAME

The name of this corporation shall be: ROBERT BOUSE PRESSURE CLEANING, INC.

ARTICLE II. CORPORATE COMMENCEMENT

The existence of the corporation shall begin on January 1, 2002.

ARTICLE III. INITIAL REGISTERED OFFICE AND MAILING ADDRESS

ARTICLE IV. CAPITALIZATION

The duration of the corporation is perpetual.


ARTICLE XI. MEETINGS BY CONFERENCE TELEPHONE


