ARTICLE I - NAME AND LOCATION OF PRINCIPAL OFFICES

Of FILED SECRETARIAN OF TANK The name of this corporation is: Rog Dot, Inc., with initial principal offices located at Street # 107, Jacksonville Beach, FL 32250.

ARTICLE II - DURATION
