The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

<u>Name</u>

The name of the corporation is SHAFDRAP MANAGEMENT, INC.

ARTICLE II

Principal Office

The principal office and mailing address of the corporation shall be 3100 University Boulevard, South, Suite, Jacksonville, Florida 32216.

ARTICLE III

Duration
