ARTICLES OF INCORPORATION
OF

FIRST. The name of the corporation is Talisman Studios Inc.

SECOND. The street address of the initial principal office of the corporation is 3952 Atlantic Blvd., G3, Jacksonville, FL 32207.

THIRD. The total number of shares of all classes of stock which the corporation shall have authority to issue is 3,000 of which 1,500 shares of par value \$.001 per share shall be designated as Common Stock and 1,500 shares of par value \$.001 shall be designated as Preferred Stock.
