**ARTICLES OF INCORPORATION
OF**

ALL AMERICAN PLASTICS OF ST. LUCIE COUNTY, INC.

BY THESE ARTICLES OF INCORPORATION the incorporator forms a corporation for profit under Florida law.

1. NAME. The name of the corporation is **ALL AMERICAN PLASTICS OF ST. LUCIE COUNTY, INC.**

2. TERM. The corporation shall exist perpetually. Corporate existence shall begin when these articles are filed with the Department of State.

3. PURPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

4. CAPITAL STOCK. This corporation is authorized to issue 100 shares of common stock for a par value of \$1.00 per share. The board of directors may dispose of the authorized but unissued stock from time to time, but every shareholder may purchase his prorata share, as near as can be done without the issuance of fractional shares, on the sale for cash of any previously unissued or new stock of this corporation at the same price at which it is offered to others.

5. REGISTERED AGENT. The initial registered agent for this corporation is **PAUL W. RUDDY**, and the initial registered office is located at 13490 Orange Avenue, Fort Pierce, FL 34982.

6. CORPORATE ADDRESS. The corporation's initial principal office is located at 920 Valley Lane, Fort Pierce, FL 34946, and the mailing address is the same.


7. DIRECTORS. This corporation shall have one director initially. The number of directors shall be fixed by the bylaws.

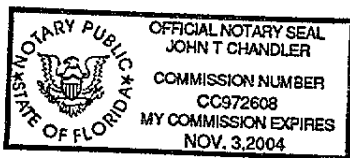


