ARTICLES OF INCORPORATION OF

The Undersigned, desiring to organize a Corporation under Chapter 607, Florida Statutes, set forth the following:

ARTICLE I

The Name of the Corporation shall be: **PLANK'S UNIQUE SERVICES INC.**.

ARTICLE II
