**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
WORKSITE COMMUNICATIONS, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation as subsequently amended is amended to read:

**ARTICLE I**

*The name of the corporation shall be **Partner Resources, Inc.** The principal office of the Corporation shall be located at 501 East Tennessee Street, Suite B, Tallahassee, Florida 32308-4906.*

2.
