**ARTICLES OF INCORPORATION**

**JESTAM, INC.**

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

**ARTICLE ONE**

The NAME of the Corporation is JESTAM, INC.

**ARTICLE TWO**

The DURATION of the Corporation is PERPETUAL.


