ARTICLES OF INCORPORATION PALMER PLAZA PROPERTY, INC.

Olac lo Mague The undersigned incorporator, for the purpose of forming a corporation under the Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I: PROPERTY, INC.

Corporate Name. The name of the corporation is PALMER PLAZA

ARTICLE II: Corporate Existence. The corporation shall exist in perpetuity commencing as of the execution of these Articles.
