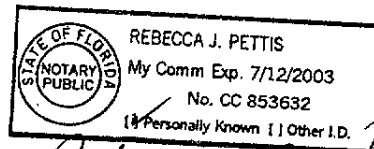


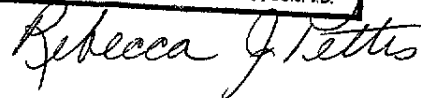
## ACCEPTANCE OF SERVICE AS REGISTERED AGENT
