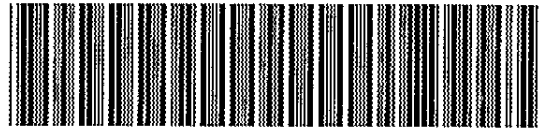

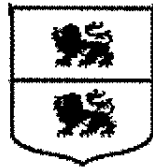



CORPORATE NAME**


The name of the Corporation is White Knight Strategies, Inc.
