ARTICLE I - NAME

The name of this corporation is Reliance Technical Services, Inc.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 325 Hampton Hills Ct., Debary, Florida 32712, and may be changed and a principal office established and/or relocated without amending these Articles of Incorporation.

ARTICLE III - PURPOSE

This corporation is organized for the purposes of designs and consulting.

VIII - PREEMPTIVE RIGHTS


The shareholders of this corporation shall be, and are hereby vested with, preemptive rights as to their shareholdings in this corporation.
