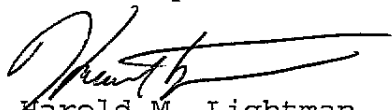

AMENDMENTS

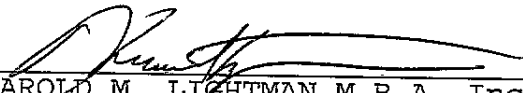

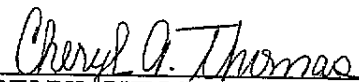

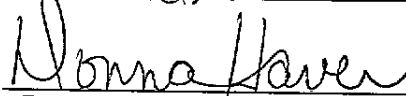
