The undersigned incorporator to these Articles of Incorporation, by these articles form a corporation for profit, pursuant to the

Laws of the State of Florida.

FIRST: The name of the corporation is **SAPORI CATERING**, **INC**.

SECOND: The period of duration of the corporation is perpetual.

THIRD: The purpose of this business is to engage in the services of catering, and other and all legitimate purposes.
