ARTICLE 111 _PURPOSE

- 1. To sell, use and advise on the use of organic non toxic fertilizers for the growing, harvesting, selling or use of food products.
- 2. To purchase or otherwise acquire, import, export, manufacture, market, sell, or otherwise dispose of, use, and generally deal and trade in and with, at wholesale or retail, any and all merchandise and equipment of every nature and description incidental thereto, and:
- To buy, sell and hold real and personal property in any state or territory necessary for the proper Conduct of its business, and:
- To purchase, hold, own, take over, maintain, develop, sell, convey, lease, mortgage, exchange, Improve and to deal in real estate and real property, or any interest and rights therein, without limit as to amount to purchase, hold, own take over, sell, hire, mortgage, pledge, chattels and chattels real without limit as to amount and to lend money in bonds secured by mortgage on real estate or to lend money on bonds secured by mortgages for future advances or real estate, and;
- Generally, to do any and everything necessary, convenient and proper for the accomplishment of any of the purposes or objects herein enumerated, or the accomplishment of any purpose or objects arising incidentally to the purposes herein mentioned, or which may at any time appear desirable or proper for the purposes, protection or best interest of the corporation, and in general to engage in any lawful business for any lawful purpose whatsoever as may be desirable, necessary or convenient.
