#### ARTICLE II. NATURE OF BUSINESS

is:

The general nature of the business to be transacted by this corporation FOR THE PURPOSE OF MECHANICAL REPAIR OF ALL MARINE PRODUCTS AND THE SALE OF RELATED PARTS.

## ARTICLE X. MISCELLANEOUS

This corporation shall have the right to amend or repeal any provision contained in these articles of incorporation and any right conferred upon the stockholders is subject to this provision.
