Thanks for your time and your patience and your time.

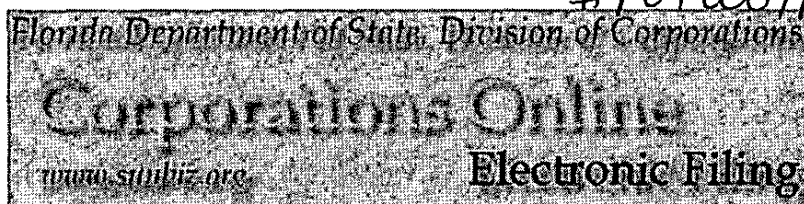

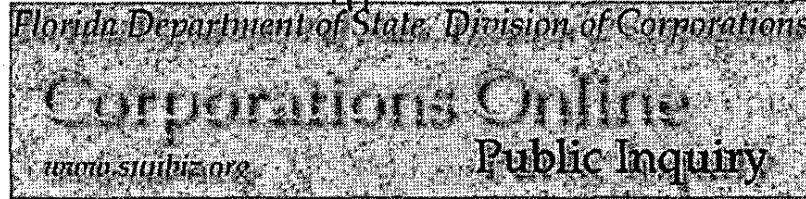
