In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Priority Notice to Owner, Inc.

ARTICLE II

The existence of the Corporation shall begin on the date of execution of these Articles.

ARTICLE III

The address of the principal office of the Corporation is Post Office Drawer 5166 Tallahassee, Florida 32314.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 30, par value \$1.00 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V

The initial street address of the Corporation's registered agent is 145 Leslie Circle, Crawfordville, FL 32327. The initial registered agent for the Corporation at that address is Linda J. Hooks.

ARTICLE VI

The initial board of directors shall consist of 2 members. This number may be increased or decreased from time to time in accordance with the Corporation's bylaws, but shall never be less than one. The names and addresses of the persons who will serve on the initial board of directors are as




