## STATE OF FLORIDA PLAN OF MERGER

(Merger of subsidiary corporation)

The following plan of merger is submitted in compliance with section 607.1104, F.S. and in accordance with the laws of any other applicable jurisdiction of incorporation.

The manner and basis of converting the shares of Subsidiary or Parent into shares, obligations, or other securities of Parent or any other corporation or, in whole or in part, into cash or other property, and the manner and basis of converting rights to acquire shares of each corporation into rights to acquire shares, obligations, and other securities of the surviving or any other corporation or, in whole or in part, into cash or other property are as follows:

On the effective date of the merger ("Effective Date"), by virtue of the merger and without any further action on the part of any corporation nor their respective stockholders, (i) each share of Common Stock of Parent issued and outstanding immediately prior thereto shall be combined, changed and converted into one (!) share of Common Stock of Subsidiary, in each case fully paid and nonassessable, and (ii) each share of Common Stock of Subsidiary issued and outstanding immediately prior thereto shall be canceled and returned to the status of authorized but unissued shares.

- 4. The merger is between Parent and Subsidiary and Parent is not the surviving corporation, therefore, upon completion of the merger each holder of shares of common stock of the Parent shall receive one share of the common stock of the Subsidiary for each share of common stock of the Parent held at the time of the merger.
- 5. Parent is the sole shareholder of Subsidiary so that there are no Shareholders of Subsidiary, who, except for the applicability of section 607.1104, F.S. would be entitled to vote and who dissent from the merger pursuant to section 607.1320, F.S., may be entitled, if they comply with the provisions of chapter 607 regarding the rights of dissenting shareholders, to be paid the fair value of their shares.
