**ARTICLE I**

The name of the Corporation ("Corporation") is Perfection Cycle, Inc.

**ARTICLE II**

The existence of the Corporation shall begin on that date which is five days after the filing date of these Articles of Incorporation.

**ARTICLE III**

**ARTICLE IV**



## ARTICLE VIII


The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
