The undersigned, in order to form a corporation under and pursuant to the provisions of the laws of the State of Florida, does hereby certify as follows:

ARTICLE I

NAME

The name of the Corporation is Starbrite, Inc.

ARTICLE II

PRINCIPAL PLACEOF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address for the Corporation shall be 20011 Emerald Coast Parkway, Destin, Florida 32541

ARTICLE III

PURPOSE
