Bylaws

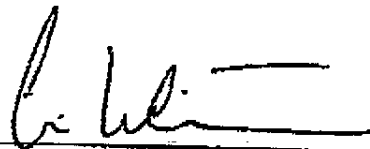

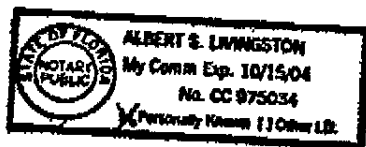
