#### ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of the Corporation is: MID FLORIDA MARINE, INC. The corporate address is 505 WEST MAIN STREET, BARTOW, FL 33830.

## ARTICLE II Duration

The duration of the Corporation is perpetual.

## Purpose

The general purposes for which the Corporation is organized are the following:
