To Whom it May Concern:

I recently received a notification from Sunbiz that changes were made to our jointly owned irrigation business, document number: P01000118306, EIN# : 30-0043170 on the date of January 5, 2024. After calling and speaking to a representative at Sunbiz informing that I did NOT make, agree, or authorize the changes on this date explaining my findings of the changes made. In the original articles of corporation from 2001-2024, It has always been myself, Angela Hart (wife) and my husband, John J. Hart who established and have run our business. Unfortunately, as of November 17, 2023, my husband was arrested and charged for domestic abuse on me and incarcerated for this for 30 days in the Lake County Florida jail. Following a no contact order for two years as well as a year probation. I have had him served divorce papers and was awarded an injunction to stay safe at the address change of my new office located at 3375 150th Place, Lake City, FL, while trying to save our business from sabotage from John who has depleted our business account to the point my attorney advised me to close our business account, Until, the courts for our divorce can decide how to handle our jointly owned business.

His additional harmful actions while the divorce proceeds brings me to why I'm writing this Statement of Fact today. I'm still co-owner of our business until the court decides otherwise. I have changed back our positions as they were as directed by your Sunbiz rep. as well as writing this letter to upload to your system as a statement of fact and to give a copy to my attorney. My husband without my knowledge or consent after I was alerted had deleted me entirely from our Sunbiz documents as of Jan. 5th. I was told he could not do this as I couldn't do that to him either. However, I am informing Sunbiz that his sister, Cynthia S. Sauer, which was not spelled correctly insinuating he had assistance making this change other than by him or his sister. She does NOT work for our business, nor has she been recently hired to take over my position. Further more, she is collecting disability and state assistance which has issued her a government cell phone which my husband is apparently using for his needs and our business which the office is based with me along with our files, documents, company phone, etc. I do consider this and your rep also agreed this is a fraudulent act and I have done everything I was instructed to do along with sending this notarized letter hoping that he will not be permitted to add her or anyone else without my knowledge and be able to delete me again in the future until our divorce is final and hopefully save our company from going under.
